LICENSE AGREEMENT

THIS LICENSE AGREEMENT (the "Agreement") between,
a licensed real estate agent of the State of New Jersey, having an address of
("USER") and Property Fax LLC, a New Jersey limited liability company ("LICENSOR"),
having an address of 360 East Main Street, Somerville, New Jersey 08876.

WITNESSETH:

WHEREAS, LICENSOR has developed the NJPropertyFax website (the "Site") and webservice (the "Webservice); and

WHEREAS, USER desires to be licensed to use the Site and Webservice; and

NOW THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, there being no actual monetary consideration for this license, LICENSOR and LICENSEE intending to be legally bound, hereby agree as follows:

The "USER" shall order a "Flood Search" (\$15 charge) from Western Technologies Group, LLC on any new real estate listings initiated by the USER on the Multiple Listing Service that are determined to be "Special Area" properties in LICENSOR's sole discretion, upon notice to USER by LICENSOR of such determination.
- 4. The Site and Webservice, and any imagery and data contained therein (collectively "NJPropertyFax") is copyright 2011 by Property Fax, LLC and is licensed, not sold, for USER non-exclusive use and subject to the provisions set forth herein. - 6. This License may not be transferred, sold or leased to a third party. USER may not retain the right to use NJPropertyFax beyond the term of this Agreement or if USER fails to meet the requirements stated herein. NJPropertyFax imagery and data provided may not be sub-licensed, published, sold or distributed in any form without express written permission from LICENSOR, except that USER may print portions of the imagery for the purpose of producing documents and/or providing information to their clients and/or customers provided there is no itemized fee charged and that LICENSOR'S copyright notice is included on such imagery.
